**SUBJECT:** Annual Benefit Statements 2016 now issued

**The purpose of this circular is to inform employers that the vast majority of 2016 Annual Benefit Statements have been issued to active members of Scotland's Police Pension Scheme.**

Circular 2016/08 advised on the process we were following to provide Annual Benefit Statements as at 31 March 2016 to active members of Scotland's Police Pension Scheme.

This circular confirms that the vast majority (over 14,500) of Police 2016 Annual Benefit Statements have now been sent to active scheme members' home addresses.

The remainder have not yet been issued due to a combination of technical issues and complexity. The outstanding statements cover part-time active members with service in the 1987 scheme who are also members of the 2015 Career Average Re-valued Earnings (CARE) scheme. Every effort is being made to resolve these outstanding problems and provide those affected with their benefit statement as soon as possible.

In any case, if active scheme members have not received their Annual Benefit Statement by 31 October 2016 please ask them to contact us.

### **Statement details**

We would like to remind colleagues that members with FULL PROTECTION from the terms of the 2015 CARE scheme only receive benefits from their existing Final Salary scheme(s) and these pension benefits only will be shown on their statement.

Similarly, active members with TAPERED or No Protection (UNPROTECTED) will have moved/move to the new 2015 CARE scheme at a specified date on or after 1 April 2015. Where individuals have moved to the CARE scheme, pension benefits for both the Final Salary and CARE arrangements will be shown on the 2016 Annual Benefit Statement.
