NHS Superannuation Scheme (Scotland) – General Medical Practitioner Interim Dynamising Factors for Financial Year 2005 -2006

Annex 1 provides the interim dynamisation factors for General Medical Practitioners for the financial year 2005/2006.

Circular No. 1/2005 and 6/2005 provided information of the revised method of calculating dynamising factors for GMPs for 2003/2004 and for subsequent years. In addition the interim medical dynamisation factors for 2003/2004 were given. Interim medical dynamisation factors for 2004/2005 were released in Circular 7/2005.

The final medical dynamisation factors for 2003/2004, 2004/2005 2005/2006 will be released in future Agency circulars.

The revised dynamising factor arrangements for General Medical Practitioners (GMP) do **not** apply to Dental Practitioners.

<u>Appendix A : Interim General Medical Practitioner Uprating (dynamising) Factors for 2005 /</u> 2006

1. Interim Increase for 2005 / 2006

The interim increase for the year ending 31 March 2006 has been agreed as follows:-

General Medical Practitioners 01.04.2005 to 31.03.2006 7.3%

2. Uprating pay to dates between 01.04.2005 – 28.02.2006 inclusive

To uprate a General Medical Practitioners (GMP) pay to any date from 01.04.2005 to 28.02.2006, the following action should be taken :-

- a) The pay for each year up to and including 31.03.2005 should first be multiplied by the factors given in Circular No. 7/2005 Annex 1, Appendix B.
- b) The total of these uprated amounts should then be increased by the appropriate percentage shown in Appendix C to this Annex.
- c) Any pay that is paid on or after 01.04.2005 should then be added to the uprated pay figure from b) above, to provide the GMPs full pensionable pay for benefit purposes.

3. Uprating pay to dates between 01.03.2006 to 31.03.2006 inclusive

To uprate a GMPs pay to any date between 01.03.2006 and 31.03.2006, the pay for each year should be increased by the relevant factor for that year shown in Appendix B to this Annex.
