NATIONAL HEALTH SERVICE SUPERANNUATION SCHEME (SCOTLAND) GENERAL MEDICAL PRACTITIONER DYNAMISING FACTORS

1. In SPPA circular 5/2004, issued in June 2004, we advised of the revised arrangements put in place under the terms of the new GMS contract for the calculation of the general medical practitioners ("GPs") Dynamisation Factor ("DF"). From the year 2003-2004, the DF will be determined by measuring the rate of change in certified NHS pensionable profits for all GPs when the accounts for the relevant year are closed.

2. Pensions awarded or estimated before GPs accounts are closed for any year will be calculated using an interim DF. The interim DF will be applied to pension calculations in the same way as the DF in previous years and any pensions put into payment using the interim DF will be revised to take account of the final DF when it is established.

3. The interim DF for any year will be set at a conservative level, the aim of which is to provide a degree of confidence level that the final DF figure will be higher. For 2003-2004 this has been agreed with a confidence level of 90%. This means that any final adjustment to pensions in payment should be upward, with any resultant arrears backdated to the date of retirement. In the event of a lower final DF being appropriate, Paymaster, SPPA's payroll partners, will write to the members affected with details of how they intend to recover any overpayment.

4. It is estimated that the rise in average GP pensionable earnings for the year to 31 March 2004 will be around 8.8%. If borne out, this will be the final DF for 2003-2004. Using the agreed 90% confidence level, this translates into an interim DF for the year of 7.2%.

5. We are having to revise the system which calculates GPs pensions as a result of the changes to the dynamisation arrangements. When this is done all GPs who have retired since April 2003 will have their pensions recalculated using the interim DF. These recalculations will be prioritised by retirement date, with earliest retirees completed first. We may not however, be able to carry out these recalculations until the finalised DF is known for 2003-2004, and if this is the case, we will do the recalculations using the final figure.





6. Information about using the interim DF to uprate GPs pensionable earnings is supplied at Annex 1 to this circular.

7. The revised DF arrangements described for GPs also applies to those practitioners to which section 17C agreements and section 2C arrangements apply. The revised DF arrangements do not apply to General Dental Practitioners.

New Interim General Medical Practitioner Uprating (dynamising) Factors for 2003-2004

1. Interim increase for 2003/2004

The interim increase for the year ending 31 March 2004 has been agreed as follows: -

General Medical Practitioners 01.04.03 to 31.03.04 7.2%

2. Uprating pay to dates between 01.04.2003 to 29.02.2004 inclusive.

To uprate a GPs pensionable pay to any date from 01.04.2003 to 29.02.2004, the following action should be taken:

a). The pay for each year up to and including 31.03.2003 should first be multiplied by the factor given in Annex 2.

b). The total of these uprated amounts should then be increased by the appropriate percentage shown against the date of retirement in Annex 4.

c). Any pay that is paid on or after 01.04.2003 should then be added to the uprated pay figure from (b) above, to provide the GPs full pensionable pay for benefit purposes.

3. Uprating pay to dates between 01.03.2004 to 31.03.2004 inclusive.

To uprate a GPs pensionable pay to any date between 01.03.2004 and 31.03.2004, the pay for each year should be increased by the relevant factor for that year shown in Annex 3.
