NHS Superannuation Scheme (Scotland) – General Dental Practitioners

As the first step towards cascading information to you, I am enclosing information on Dental Practitioners Pay and Dynamising factors.

DENTAL PRACTITIONER PAY AND DYNAMISING FACTORS FOR YEAR 2006-2007

Annex 1 of this circular contains details of the Dynamising Factors for 2006 – 2007 for General Dental Practitioners. These factors are for information only and SPPA will apply the necessary increases.

NEW LIMIT ON MAXIMUM ALLOWABLE REMUNERATION (MAR) FOR DENTAL PRACTITIONERS

The maximum allowable remuneration (MAR) allowed for pension purposes with effect from 1 April 2006 to 31 March 2007 has been agreed at £115,800.00. This figure, however, exceeds the pension scheme earnings cap on pensionable pay. This means that the pensionable earnings of any Dental practitioner who joined the NHS Pension Scheme on or after the 1 June 1989 is subject to the pension scheme earnings cap of £108,600.00 for the tax year 2006/2007.

Appendix A: General Dental Practitioner Uprating (dynamising) Factors for 2006 / 2007

1. Increase for 2006 / 2007

The increase for the year ending 31 March 2007 has been agreed as follows:-

General Dental Practitioners 01.04.2006 to 31.03.2007 3.00%

2. Uprating pay to dates between 01.04.2006 – 28.02.2007 inclusive

To uprate a General Dental Practitioners pay to any date from 01.04.2006 to 28.02.2007, the following action should be taken:-

- a) The pay for each year up to and including 31.03.2006 should first be multiplied by the factors given in Appendix B.
- b) The total of these uprated amounts should then be increased by the appropriate percentage shown in Appendix C to this Annex.
- c) Any pay that is paid on or after 01.04.2006 should then be added to the uprated pay figure from b) above, to provide the practitioner's full pensionable pay for benefit purposes.

3. Uprating pay to dates between 01.03.2007 to 31.03.2007 inclusive

To uprate a Dental Practitioners pay to any date between 01.03.2007 and 31.03.2007, the pay for each year should be increased by the relevant factor for that year shown in Appendix D to this Annex.
