Dear Colleagues

Draft regulations amending the Firefighters' Pension Scheme (Scotland) Regulations 2015 and the Firefighters' Pension Scheme (Amendment and Transitional Provisions) (Scotland) Order 2016.

Content

The purpose of this consultation is to seek the views of Firefighters' Pension Scheme stakeholders on draft amendments to the above regulations. The amendments cover the following areas:

Amendment to Part 5 (retirement benefits)

Regulation 71A of the 2015 Regulations deals with transition members' entitlement to commute part of any lower tier ill-health pension that they may be awarded into a lump sum. The current regulation sets out certain provisions relating to the commutation of a lump sum for members who have transitioned from the 2006 Scheme to the 2015 Scheme. This amendment makes comparable provision for members transitioning from the 1992 Scheme.

Amendment to Part 6 (death benefit)

Regulations 78 and 92 deal with survivor benefits, making it clear that three months' service is sufficient to achieve qualification and stipulating, where applicable, that bereavement pension is for the benefit of eligible children.

Amendment to Part 8 (contributions)

Regulations 111 and 119 correct minor drafting errors respectively.

Amendment to Part 11 (appeals and determinations)

Regulation 144 (4)(b), the wording is corrected dealing with medical appeals.

Amendments to Schedule 2 (transitional provision)

Paragraphs 37 and 38 of Schedule 2 to the 2015 Regulations include provisions that deal with the position of members who are being considered for ill-health retirement by an independent qualified medical practitioner at the time of their transition date, and who subsequently continue as active members of the 2015 Scheme. These members join the 2015 Scheme at the time specified under such provisions. The position of members who are being considered for ill-health retirement by an independent qualified medical practitioner at the time of their transition date, who are subsequently granted an ill-health award and consequently retire requires amendment. Under the amendments to paragraphs 37 and 38, such members would remain in their existing pension scheme, avoiding the necessity for a minimal period of membership of the 2015 Scheme.

The Firefighters' Pension Scheme (Amendment and Transitional Provisions) (Scotland) Order 2016

Minor necessary amendments are being made to ensure that, following the implementation of that Order, firefighters continue to pay contributions in relation to additional pension benefit as appropriate and that the Scottish Fire and Rescue Service pay the appropriate level of employer contributions.
