# The National Health Service Pension Scheme (Scotland) Regulations 2013 (2008 section)

I attach, for your consideration and comments, a copy of the draft regulations which will consolidate "The National Health Service Pension Scheme (Scotland) Regulations 2008 SSI 2008/224" and it's amending instruments to date.

This consolidation is of the 2008 section of the scheme only and does not include any amendments or changes to the 1995 section of the scheme (The 2011 regulations). The regulations do not include any new policy and make technical changes only where required to tidy up the document as a result of the changes made by the amending instruments.
