# The Teachers' Superannuation and Pension Scheme (Scotland) Amendment Regulations 2019

Made	2019
Laid before the Scottish Parliament	2019
Coming into force	[1st April 2019]

The Scottish Ministers make the following Regulations in exercise of the powers conferred by sections 9 and 12 of, and Schedule 3 to, the Superannuation Act 1972 ("the 1972 Act")( $\mathbf{a}$ ), and sections 1 (1) and (2)(d) of, and paragraph 4 (b) of Schedule 2 to, the Public Service Pensions Act 2013 ("the 2013 Act")( $\mathbf{b}$ ),, and all other powers enabling them to do so.

In accordance with section 9(5) of the 1972 Act, Scottish Minister have consulted with representatives of education authorities and of teachers and with such representatives of other persons likely to be affected by these Regulations as appear to them to be appropriate. In accordance with section 9(1) of the 1972 Act, the Treasury has consented to these regulations(c).

In accordance with section 21(1) of the 2013 Act, the Scottish Ministers consulted the representatives of such persons as appeared to the Scottish Ministers likely to be affected by these Regulations.

In accordance with section 3(5) of the 2013 Act, these Regulations are made with the consent of the Treasury.

# Citation and commencement

**1.**—These Regulations may be cited as the Scottish Teachers' Superannuation and Pension Scheme (Scotland) Amendment Regulations 2019 and come into force on 1 April 2019.

# Amendment to The Teachers' Superannuation (Scotland) Regulations 2005

**2.**—The Teachers' Superannuation (Scotland) Regulations 2005(**a**) are amended in accordance with Regulation 3.

**3.**— In Regulation H3 (Employers' contributions), in paragraph (3)(a) for "17.2%" substitute "22.4%".

## Amendment to the Teachers' Pension Scheme (Scotland) (No.2) Regulations 2014

**4.**—The Teachers' Pension Scheme (Scotland) (No.2) Regulations 2014(**b**) are amended in accordance with these Regulations 5 to 11.

## **Amendment of Regulation 3 (Interpretation)**

**5.**—In Regulation 3 (Interpretation), in definition of "standard accrual rate" for "1/57<sup>th</sup>" substitute "1/49.6".

#### Amendment of Regulation 51 (Account to specify amount of pension for a financial year)

**6.**—In Regulation 51( Account to specify amount of pension for a financial year), in paragraph (3)(a), for  $1/57^{th}$  substitute " $1/49.6^{th}$ ".

#### Amendment of Regulation 114 (Annual rate of total incapacity pension)

7.—In Regulation 114 (Annual rate of total incapacity pension), in paragraph (1), for "57" substitute "49.6".

#### Amendment of Regulation 142 (Enhancement of surviving adult pension)

**8.**—In Regulation 142 (Enhancement of surviving adult pension), in paragraph (2)(b), for " $1/57^{\text{th}}$ " substitute " $1/49.6^{\text{th}}$ ".

#### Amendment of Regulation 149 (Enhancement of child pension)

**9.**—In regulation 149 (Enhancement of child pension), in paragraph (2)(ii), for "1/57<sup>th</sup>" substitute "1/49.6<sup>th</sup>".

# **Regulation 186 (Employers' contributions)**

10.— In Regulation 186 (Employers' contributions), for paragraphs (b) and (c) substitute

- "(b) 17.2% from 1<sup>st</sup> September 2015 to 31 March 2019;
- (c) 22.4 % from 1 April 2019;

(d) at the rate determined in each successive valuation report under paragraph 1 of Schedule 4 with effect from a date to be notified to employers by the scheme manager.".

# Amendment of Schedule 2 (Scheme flexibilities)

**11.**—In Schedule 2, paragraph 1 (Interpretation) in the definition of "faster accrual rate" for "means  $1/45^{\text{th}}$ ,  $1/50^{\text{th}}$  or  $1/55^{\text{th}}$ " substitute "means 1/X, 1/Y or 1/Z.

# Amendment to the Teachers' Superannuation and Pension Scheme (Additional Voluntary Contributions (Scotland) Regulations 2017

**12** The Teachers' Superannuation and Pension Scheme (Additional Voluntary Contributions (Scotland) Regulations 2017(**a**) are amended in accordance with these Regulations 14 and 15.

# Amendment of regulations 12 (Retirement and dependants' pensions)

13.—In regulation 12 (Retirement and dependants' pensions) —

(a) in paragraph (1), after paragraph (b) insert "(c) in the case of a person who applies for retirement benefits under regulation E6(5) the 2005 Regulations or for an ill health pension under the 2014 Regulations (as defined in regulation 3 of those regulations);"

(b) in paragraph (11) for "(Z)" substitute "(2)".

# Amendment of regulations 14 (Pension sharing on divorce)

**14.**—In regulations 14 (Pension sharing on divorce), in paragraph (8) for "12(5), (6)" substitute 12(6).

# EXPLANATORY NOTE

(This note is not part of the Regulations)

Regulation 3 makes an amendment to The Teachers' Superannuation (Scotland) Regulations 2005. The purpose of the amendment is to increase the Employers' Contribution rate from 1 April 2019 following the 2016 Valuation.

(a) S.S.I. 2017/283.

Regulations 4 to 11 make a number of amendments to the Teachers' Pension Scheme (Scotland) (No.2) Regulations 2014 Regulations 3, 51, 114, 142, 149 of those Regulations are amended to change the accrual rate to 1/49.6<sup>th</sup> following the 2016 Valuation. This will result in an increase in pension accrual each year. An amendment to Regulation 186 provides for the increase in employers' contributions following the 2016 Valuation. Schedule 2 is also amended to change the faster accrual rate following the 2016 Valuation

Regulations 12 to 14 make minor changes to the Teachers' Superannuation and Pension Scheme (Additional Voluntary Contributions) (Scotland) Regulations 2017.
