How do I sign up for this service?

All you need to do is to complete the "Mandate Form" and return it to your pension administrator directly.

To ensure that future payments are not delayed or misdirected, please let your pension administrator know immediately if your account details change.

What does WorldLink® Payment Services offer?

WorldLink® is an international payments service that enables overseas pensioners to receive payments directly into their bank accounts via secure electronic means.

Via the WorldLink platform, you can apply to be paid in local currency bank accounts in over 100 countries. Your pension administrator will ask its paying agent, Citibank Europe plc, to convert your regular pension payment into the local currency equivalent amount and pay directly into your account.

Advantages to the Pensioner

- Direct credit to a personal account in local currency
- Elimination of delays in obtaining funds that occur when using cheques as payment instruments, due to faster delivery of the electronic payment
- Lower transaction charges and competitive exchange rates

How does it work?

If you decide to benefit from this service, you will be required to complete the mandate and send it back to your pension provider.

Once this has been done, your pension administrator will ask Citibank Europe plc to pay you in the currency you have selected. Citi will process your application and transfer funds into your bank account in the chosen currency on behalf of its client, your pension administrator.

Any account at a bank or financial institution that accepts direct deposit payments can receive these payments. The account must be in the name of the beneficiary or in the joint names of the beneficiary and his or her spouse.
