Procedure for scheme regulations

Public Service Pensions Act 2013

Under Section 21(1) of the above act, before making scheme regulations the responsible authority must consult such persons (or representatives of such persons) as appear to the authority likely to be affected by them.

Under Section 21(2), the responsible authority for each scheme must publish a statement indicating the persons that the authority would normally expect to consult under 21(1).

Scottish Ministers are the responsible authority for the Firefighters', Local Government, NHS, Police, and Teachers' pension schemes in Scotland. The persons Scottish Ministers would expect to consult in respect of each scheme are set out below:
