About This Consultation

This consultation document seeks views on draft amendments designed to allow for the phased withdrawal of independent schools from the Scottish Teachers' Pension Scheme (STPS). The purpose of phased withdrawal is to enable independent schools to continue participating in the STPS for existing members while reducing the financial pressures, which may be faced by some, as a result of any increases to the employer contribution rate.

Duration of Consultation

Extensive consultation on this policy was undertaken in 2022. This short technical consultation will run for a period of two weeks commencing on 27 April 2023 and ending on 11 May 2022.

Introduction

- 1.1. This is a technical consultation on draft amendments to deliver the policy to allow independent schools to withdraw from the Scottish Teachers' Pension Scheme on a phased basis.
- 1.2. On behalf of the Scottish Ministers, the Scottish Public Pensions Agency (SPPA) undertook a <u>consultation</u> between 6 May 2022 and 29 July 2022 on proposals to allow for the "phased withdrawal" of employers from the Scottish Teachers' Pension Scheme (STPS). SPPA published the <u>response</u> to this consultation in January 2023.
- 1.3. Under existing regulations, a school that participates in the STPS must enrol all eligible teachers into the scheme. Should the school wish to cease being a participating employer in the STPS, they must do so in full, meaning all active members would have benefits preserved in the scheme, and given access to alternative provision. Phased withdrawal would allow participating employers to cease enrolling new employees into the STPS whilst allowing existing members to retain their membership of the scheme. The consultation sought views on the merits of the Scottish sector having access to a provision in line with that introduced in England and Wales in August 2021.
- 1.4. Having taken into account the views of the independent schools sector and other stakeholders, SPPA set out in the Scottish Government's response to the consultation that amendments would be made to the scheme to deliver this policy. The Scottish Teachers' Superannuation and Pension Scheme (Miscellaneous Amendments) (Scotland) Regulations 2023 will deliver these changes.
- 1.5 In introducing these changes, the Scottish Government recognises it has no vires to determine the overarching legal or financial framework for public service pensions. Decisions on the methodology and assumption by which scheme valuations are undertaken and employer contribution rates set are a matter for Westminster. Scottish Ministers maintain a full commitment to public service pensions that are affordable, sustainable and fair and a strong view that the STPS is a valuable part of the reward and remuneration package for teachers in Scotland. The features of the scheme make active membership of it a valuable recruitment and retention tool, and the benefits earned over the course of a teacher's career will provide protection and valuable benefits payable for life during retirement.
- 1.6. Pension provision offered to teachers in the independent education sector is ultimately a decision for the boards of independent schools. However, the Scottish Government hopes that for the above reasons full consideration is given to the implications of withdrawing from the scheme, either in full or on a phased basis.



This should include full consultation with teaching staff well in advance of any option of phased withdrawal being taken up.

1.7. Following this consultation, Scottish Ministers will bring forward the changes and lay them before the Scottish Parliament in June 2023. SPPA will draft supporting guidance on the process that schools should undertake in exercising this option. Schools that opt for a phased withdrawal may allow existing teaching staff to remain members of the STPS, whilst providing new recruits with suitable alternative pension provision. Scottish Ministers believe that all current teaching staff should be permitted access, so that teachers who have currently opted out of the scheme should be provided with the opportunity to re-enrol, and teachers currently on longer term non-pensionable leave should retain access upon their return to employment.

Draft Regulations

- 2.1. The amendments broadly align with similar changes introduce in England and Wales., and are made to both the Teachers Superannuation (Scotland) Regulation 2005 ("the 2005 regulations") and the Teachers' Pension Scheme (Scotland) Regulation (no.2) 2014 ("the 2014 regulations").
- 2.2 The amendments introduce a new category of "accepted school" employer described as an "accepted phased withdrawal school". Regulations 2 to 6 amend the 2005 Regulations to enable any accepted school, which is an independent school that participates in the scheme under the 2005 regulations, which previously had to cover all teaching staff, to limit coverage to staff employed, or absent on limited grounds, as at a date agreed by the Scottish Ministers, following application on behalf of the school. Regulations 7 and 8 make similar amendments to the 2014 regulations in relation to accepted schools that participate in the pension arrangements covered by those Regulations.

Consultation process
