2023 Annual Benefit Statement Schedule

2015 Remedy

On 1 April 2022 the legacy NHS Schemes were closed to any future pension build-up and members were moved into the reformed 2015 pension scheme.

Members who are <u>Eligible</u> (go to the section 'Am I eligible') will have the chance to choose between legacy or reformed scheme benefits at or following retirement.

2023 ABS for members who are not eligible for 2015 Remedy

Members who are not eligible for 2015 Remedy will get an ABS by the end of August. These will be available on <u>MyPension Online</u>.

2023 ABS for members who are eligible for 2015 Remedy

Members who are working and contributing to a pension and or have deferred their benefits will receive a **dual annual benefit statement from August 2024**. This will provide estimates of benefits in both the Legacy and reformed (CARE) schemes.

The SPPA is currently preparing to offer this choice to eligible members and getting everything ready to deliver dual Annual Benefit Statements in 2024. As a result, we will not be issuing ABS for 2023 to those members who are eligible for Remedy as these will have limited value. From 1 October when new regulations are in place, this will be replaced with a <u>Remedial Service Statement</u> (go to the section 'How will I make my choice'.)

In the absence of an Annual Benefit Statement this year members can self-serve and use our Remedy calculator to get an estimate of their pension benefits for the Remedy period.

A Remedy calculator is available to compare legacy and reformed scheme benefits. This is the only service available at the present time for members who are eligible for Remedy and wish to obtain an estimate.
