1. Welcome

2. NHS and Teachers' Schemes Annual Reports and Accounts

- 2.1 The Chair advised the Audit and Risk Committee (ARC) had met earlier, with Audit Scotland and Internal Audit in presence, and had recommended the approval of the accounts. The Board noted the recommendations in the Audit Scotland Report.
- 2.2 The Board discussed the following in relation to the report:

 - The need for more time to be available for Board members to review the final documents before the meeting
 - Engagement with Scottish Government on the overspend caused by accounting adjustments based on Government Actuary's Department figures.
- 2.3 The Chair highlighted ARC had commended the Annual Reports and Accounts to the Management Advisory Board stating, on the whole, the reports were fair, balanced and understandable representations and recommended that the Management Advisory Board recommend to the Accountable Officer that he sign the Accounts.
- 2.4 The Board recommended to the Accountable Officer that he sign the accounts.
