

Apply to buy back opted-out service – 2015 Remedy

This form is only for people with eligible service who opted out of their public service pension scheme between 10 March 2012 and 31 March 2022.

These dates refer to 2015 Remedy. You can read more about 2015 Remedy on our website at <https://pensions.gov.scot/2015-remedy>.

You can use this form to buy back the full – or partial – amount of your opted-out service that falls within these dates.

Paying money back

If you apply to buy back opted-out service and are accepted, we'll calculate what the cost will be to you. This amount will include interest.

Changing your mind

You can change your mind about buying back opted-out service once you know what it'll cost you.

Closing date for applying

You have 12 months from the date on your RSS to apply.
